A foundation (also a charitable foundation) is a legal category of nonprofit organization that will typically either donate funds to and support other organizations, or provide the source of funding for its own charitable purposes. Foundations incorporate public foundations to pool funds (e.g. a community foundation) and private foundations who are typically endowed by an individual or family.
